Drivers will be required to certify that the information they give is accurate and true, and that false or missing information may, and probably will, invalidate their Medical Certificate. Drivers can look over the Official Medical Examination Report 649-F (6045) that your Medical Examiner will fill out and transmit to the DOT after your physical.

A Department of Transportation (DOT) physical examination must be conducted by a licensed "medical examiner" listed on the Federal Motor Carrier Safety Administration (FMCSA) National Registry. The term includes, but is not limited to, doctors of medicine (MD), doctors of osteopathy (DO), physician assistants (PA), advanced practice nurses (APN), and doctors of chiropractic (DC).

Your blood pressure needs to be under 140/90. Stage 1 hypertension , blood pressure between 140/90 - 159/99: 1-year medical certificate, must be renewed every 12 months. Stage 2 hypertension , blood pressure between 160/100 - 179/109: 3 month medical certification. Full disqualification if not under control after 3 months, until controlled.

DOT physical exams are generally administered by approved doctors of medicine, physician assistants, doctors of chiropractic, advanced practice nurses and doctors of osteopathy. Even if the CDL physical test is typically administered on a 24-month basis, certain drivers may still be required to retake the exam on a more frequent basis if they have a condition that must be monitored regularly.

During a DOT physical, medical examiners look for deformities that might interfere with breathing or . swallowing. These abnormalities and certain risk factors are predictors of sleep apnea and could prompt an examiner to order a sleep test. Risk factors include (but are not limited to): – BMI – Hypertension – Age – Receding chin

The medical conditions the physical tests for includes heart-related issues, mental or neurological conditions, vision, hearing, and if the driver has any substance abuse issues. Once the DOT physical is done and you're cleared to drive, you will be given a medical examiner's certificate (MCE) for a maximum of 24 months.

A DOT driver must show he/she is able to wear his/her machine for 4 hours or more per night, at least 70% of the time. Usually a doctor can review the download and send a letter to your DOT physician stating you are compliant. The DOT physician will issue a certificate based on compliance.
